TERMS AND CONDITIONS

We welcome visitors to our Cemetery; however, we do ask you to abide by the regulations as set out below. These regulations have been formulated and are in place for your safety and the safety of others.

IMPORTANT:

- Deed Holder Is the Holder of the Right of Interment to use a particular grave or memorial positions for the interment of deceased remains and display a memorial tribute.
- The Holder of Right of Interment must authorise any communication, written or verbal, with the cemetery.
- The 'Right of Interment' can only be transferred to another person with the approval of The Trust. The Trust reserve the right to reject any transfer at its discretion.
- The Trust reserves the right to change regulations at its discretion and reserves the right to specify different regulations and restrict the use of monuments and memorials in defined areas of the cemetery.
- All graves and memorial positions are part of cemetery property, and the property always remains with the cemetery.
- Please remember to advise the cemetery office of any change of address and contact details.
- Any items of memorabilia placed at a site within the cemetery grounds is done at the owners own risk, and the cemetery is not responsible for any loss or damage.
- A temporary grave marker such as a wooden cross can be placed at the burial locations up to a period of 12 months from the date of interment. After that any grave markers will be removed by ground staff.
- Some cultures use a temporary structure to light candles at a grave site. For this use, a temporary candle box constructed of non-combustible is materials is permitted while arrangements for a permanent memorial are being made. No flame is to be lit during a Total Fire Ban, and any restrictions during the Fire Danger Period must be complied with.

Balloons are not permitted.

Burial:

Perpetuity – All graves purchased are in 'Perpetuity' (forever).

Cremation:

- Memorial sites are purchased as 25-year tenure or in perpetuity.
- Rose Replacement, responsibility of Holder of Right of Interment after 2 years.

THE FOLLOWING IS PERMITTED WITHIN THE CEMETERY	THE FOLLOWING IS <u>NOT</u> PERMITTED WITHIN THE CEMETERY:
 Natural and Artificial flower arrangements in good conditions can be placed on grave and memorial sites, in vases located within the grounds. Please limit the vases on each site to two Approved memorials. Small unbreakable mementos placed onto your memorial are placed on site at own risk. All monuments and plaques constructed according to monumental regulations. Dogs only permitted on a leash and all deposits removed. 	 Planting of a replacement rose at memorial sites. Picking of Roses and other flowers in the cemetery grounds is an offence. Removal of flowers from graves and memorials and placed on other sites is prohibited Sprinkling of 'Ashes' not permitted at any time, No planting of plants of any kind permitted without permission of the ground staff Glass jars or vases not permitted to be used. Alcohol in cemetery grounds is strictly prohibited. Items left at memorials that if fall may cause injury. Flowers and any other items left on memorials in non-approved containers. Unauthorised (Non-Standard) plaques not permitted and will be removed. Items in disrepair such as fans, flags, figurines, dolls containers etc will be removed. Placement of Snail Bait or other poisons within the cemetery grounds.

Grounds Staff are in attendance daily Monday to Friday, 8.00am to 3.30pm. Office Hours are Tuesday and Friday 9.30am to 2.30pm and Wednesday 9.30am to 12.30pm.
